Vice Chair Taylor established that there was a quorum present and opened the Community Advisory Committee of Valley Clean Energy Alliance in a meeting on Thursday, October 23, 2025 beginning at 5:00 p.m., held at the City of Davis Conference Room, inside the Community Chambers building, located at 23 Russell Boulevard, Davis, California 95616.

Welcome and Roll Call

Welcome Vice Chair Keith Taylor welcomed everyone and announced that he would run

the meeting because Chair Rahul Athalye is running late. He reminded everyone that VCE is still seeking candidates to fill the unincorporated Yolo

County CAC seat.

Public Comment / Introductions

There were no verbal or written public comments on items not on the agenda

and on Consent Agenda items.

Brief VCE staff Report

Task Group Reports:

(David Springer arrived at 5:05 p.m.)

- Legislative & Regulatory CAC Member Lorenzo Kristov informed those present that the Task Group continues to meet every 2 week scheduled. He informed those present that the Los Angeles Times had an article on SB 541 (Affordability) and bailouts to IOUs for fire liabilities. The Task Group also worked on the draft 2026 Legislative & Regulatory Platform.
- 2. <u>Programs & Outreach</u> CAC Member Diccon Westworth informed those present that the "Charge Your Ride" was finalized and is being presented tonight to the CAC for a recommendation. VCE Staff



Rebecca Kuczynski informed those present that there have been impersonators as VCE employees going door to door, which VCE never does, and this initiated a scam alert on VCE's webpage and the plan to implement a fraud page on the website.

3. <u>Strategic Plan</u> – VCE Staff Edward Burnham announced that the Major Update of the Strategic Plan 2026-2029 was adopted by the Board at their October 14, 2025 Special Meeting.

Staff Report: Mr. Burnham announced that the Board at their October 2025 Special meeting received an end of session legislative update from Mark Fenstermaker of Pacific Policy Group, VCE's Lobbyist consultant; authorized VCE's participation in the Smart Home Energy and Load Flexibility (SHELF) Pilot program with UC Davis California Lighting Technology Center (CLTC) and Panasonic; approved the Large Electric Load Customer Service Policy; and, as mentioned above approved the Strategic Plan Major Update. It was announced that two events are coming up: 1) Davis Downtown Treat Trail on Friday, October 31st (Halloween) in downtown Davis and 2) the Salmon Festival on Saturday, November 11th in Winters. Mr. Burnham announced that VCE received an investment grade credit rating of A- Stable from S&P Global Ratings. Staff explained the benefits and what this means to VCE and informed those present that a Press Release is forthcoming and the A-credit rating is on VCE's website. Lastly, offers have been extended to a few candidates for various positions and Staff are hoping to make some announcements soon.

Item 10: Review, provide feedback and make recommendation to the Board to approve Phase 2 of VCE's Electric Vehicle Rebate Program ("Charge Your Ride").
(Discussion/Action)

VCE Staff Rebecca Kuzynski provided an overview of VCE's Electric Vehicle (EV) Rebate Pilot Programs background, timeline, and engagement process leading up to the proposed "Charge Your Ride" (Phase 2) EV program. The Pilot Program's goals, design, budget options, and scenarios were reviewed. In summary, the "Charge Your Ride" program elements include incentives for pre-owned EVs for low income customers, incentives for multi-family charging outlets and stations, and technical support to support multi-family property owners.

The CAC and Staff discussed and provided feedback on many topics, including: outreach efforts regarding the program; program eligibility; data on used EV's; technical support for participants; permitting for multi-family participants; and, flexibility of the program moving forward.
