



## Valley Clean Energy (VCE) Electric Vehicle Rebate Program TERMS AND CONDITIONS and APPLICATION

### 1. ELIGIBILITY:

- a. Residential customers may apply. Applicant must be an existing VCE customer with an account that is paid and current as of the date of application.
- b. Applicants must have proof of residence at the address of record in their VCE account. Residence may be established by providing a utility bill or a government-issued identification card (e.g., a driver's license).
- d. Applicant shall be eligible under and approved by the California Clean Vehicle Rebate Project (CVRP) prior to submitting VCE rebate application.
- e. Application including all supporting documents must be received no later than 3 months after approval by the State of California for rebate under the CVRP.
- f. Only electric passenger cars and trucks approved by the CRVP will be eligible for a rebate through VCE.
- g. Applicants approved by the CVRP are eligible to receive \$2,000 - \$2,500 for a passenger electric vehicle, or \$4,000 if Applicant meets CVRP's low-income qualifications.

### 2. RESTRICTIONS: One rebate per residential account service address. For multifamily residences with a shared electric account, one rebate per unit number. VCE staff and Board of Directors are ineligible to apply.

### 3. REBATE PAYMENTS: Rebate payments will be made by check made payable to Applicant and will be issued within 30 days following application approval. VCE reserves the right to request a completed and signed IRS Form W-9 before releasing the rebate payment.

### 4. LIMITATIONS: Rebates are subject to funding availability. Applications will be processed, and rebates issued, on a first-come, first-served basis (except for income-qualified applications, which will be given priority) until funding is depleted or the VCE rebate program is terminated. Submittal of a completed application does not guarantee receipt of a rebate. Rebates may be subject to delays. Applicants placed on a waiting list may qualify for the rebate if additional funds become available. VCE reserves the right, in its sole discretion, to determine the completeness of an application, to reject any application, to deny a rebate payment after approval to any applicant deemed by VCE to be in violation of any term or condition of either the VCE program or the CVRP, or to deny a rebate payment after approval to any applicant deemed by VCE to have intentionally misrepresented information provided with the application.

### 5. FRAUDULENT APPLICATION: Any rebate issued that VCE later determines was obtained through fraudulent action of Applicant shall be refunded by Applicant to VCE in full. VCE shall be entitled to an award of attorney's fees and costs in the event it brings an enforcement action to collect such fraudulently procured funds.

### 6. TAX LIABILITY and CREDITS: VCE is not responsible for payment of any taxes which may be imposed on the customer as a result of the rebate. The customer is solely responsible for payment of all applicable taxes and for identifying and applying for tax credits if any are available.

### 7. DISPUTES: Except where otherwise limited by law, VCE reserves the right, in its sole discretion, to make final determinations regarding any disputed issues, including but not limited to, eligibility and rebate amount.

### 8. PROGRAM CHANGES: VCE reserves the right to change, modify, or terminate this rebate program at any time without liability. VCE's program may experience delays.

### 9. PROGRAM EXPIRATION: The rebate program will expire upon the occurrence of the earliest of: (i) depletion of funds, or (ii) termination by VCE of this rebate program.

### 10. WAIVER and DISCLAIMER: VCE makes no guarantees, representations, warranties, or endorsement, express or implied, regarding any vehicle acquired and subject to a rebate under this rebate program. Use of any such vehicle is at the applicant's risk. Applicant is solely responsible for all costs associated with the purchase, maintenance, and use of any vehicle. The applicant releases and holds VCE harmless from any and all loss or damages the applicant may suffer arising from applicant's participation in this rebate program and acquisition of



an electric vehicle. Applicant expressly waives the provisions of California Civil Code section 1542, which provides: "A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party."

- 11. CUSTOMER INFORMATION DISCLOSURE AUTHORIZATION:** By signing and submitting the Rebate Application, Applicant affirms that they are a VCE customer, or reside in the home with a VCE customer, and authorizes VCE's use and disclosure of customer's name as a participant in this rebate program. VCE may request that Applicant participate in testimonials or interviews, provide visual materials (photos, videos, etc.) or contribute to other marketing and promotional activities related to the Applicant's rebate. Participant's participation or contribution in this manner is optional.
