It allows any Net Energy Metering (NEM) customer to donate the value of their excess energy production to one of the Yolo charities we're partnering with: Yolo County Housing Authority and Habitat for Humanity of Greater Sacramento (includes Yolo County).

We're excited to report that in this past quarter we've collectively donated over \$1,000 to the program already. Some of that came from the generous donations of 3 anonymous donors; we also added donations from OhmConnect's Spring 2022 customer sign-ups—\$10 for each customer enrollment was donated to charity during the Spring 2022 promotion period. *This compares electricity costs for an average residential customer in the VCE/PG&E service area (Woodland, Winters, Davis and unincorporated Yolo County) with an average monthly usage of 513 kilowatt-hours (kWh). This is based on a representative 12-month billing history for all customers on E-1 rate schedules for PG&E and VCE's published rates as of March 2022.

Generation Rate is the cost of creating electricity to power your home. The generation rate varies based on your energy provider and the resources included in your energy provider's generation supply.

PG&E Delivery Rate is a charge assessed by PG&E to deliver electricity to your home. The PG&E delivery rate depends on your electricity usage, but is charged equally to both VCE and PG&E customers.

PG&E PCIA/FF The PCIA is a charge to ensure that both PG&E customers and those who have left PG&E service to purchase electricity from other providers pay the above market costs for generation resources that were procured by PG&E on their behalf. "Above market" refers to expenditures for electric generation resources that cannot be fully recovered through sales of these resources at current market prices. PG&E acts as a collection agent for the FF surcharge, which is levied by the California Public Utilities Commission on behalf of cities and counties in PG&E's service territory for all customers. PG&E bundled customers pay the PCIA and FF fees associated with the most currently available vintage year. PG&E charges VCE customers the PCIA and FF fees based on the year that they transitioned to VCE service. Visit valleycleanenergy.org/rates for more information.
