IOUs, particularly PG&E, initiated an unprecedented level of PSPS events last year, causing Californians to wonder if a lack of power for days or even weeks at a time will be an annual occurrence. VCE, working with our member jurisdictions, have identified more than 20 facilities throughout Yolo County that are suitable locations to serve as community resource centers (CRCs), gathering points for our communities to access basic needs such as water and electricity during a PSPS event.
