VCEA staff, in coordination with SMUD, have produced the attached Budget Exhibit C to the VCEA/SMUD Master Services Agreement. The new Budget Exhibit does not change contract costs which are currently included in individual contract Task Orders. The purpose of the Budget Exhibit is to consolidate contract costs in this exhibit for ease of review and clarity.

EXHIBIT C

BUDGET

The budget shown in Table 1 below provides the SMUD fees and costs associated with delivery of the scope of services outlined in the Master Professional Services Agreement dated ______ and detailed in the accompanying Task Orders. Based on its August 2017 Comparative Analysis of the SMUD services proposal and budget, VCEA staff finds that SMUD's fees and costs in each service area are below or commensurate with current fees paid by operational CCAs for similar services.

In addition, as outlined in Section 8.7 of the Master Professional Services Agreement, SMUD has established a deferred payment period that commences on October 1, 2017 and runs through September 30, 2018; a fee of 2% on all deferred payments for advance work began accruing on October 1, 2017. This deferment fee replaces pre-launch start-up seed capital that would otherwise be required by VCEA and is commensurate with the interest rates of start-up seed capital lines of credit offered by banking service providers that responded to the 2017 VCEA Banking Services RFP.

Table 1 summarizes the fees and costs by Task Order. This Exhibit will be amended to add budget and scope information when new Task Orders are approved by both parties.
