

#### **VCE Purchases Local Renewables**

Valley Clean Energy is entering into two local power purchase agreements (PPAs), making good on our promise to solicit local renewables to supply up to 25% of its targeted 2030 renewable goal of 80%. These two projects will satisfy over 40% of this target.

VCE's PPA with Putah Creek Solar Farms LLC in Winters will procure 3 megawatts (MW) of solar co-located with a battery energy storage system in Yolo County. Another PPA, with Gibson Renewables LLC near Esparto in Madison, will procure 20 MW of solar combined with a battery energy storage system. Both projects are "pollinator friendly," with extensive plantings that will attract pollinators such as bees and monarch butterflies.

These two projects (Putah Creek Energy Farm & Gibson Solar) contribute 10% towards the Yolo County Climate Action Plan 2021 carbon reduction goals and will meet nearly 10% of VCE's load.

Planned educational uses at the Putah Creek facility include research to identify sustainable planting under solar arrays for agricultural and power production purposes. Owners and operators are multi-generational Winters residents and farmers (Martinez Orchards, Inc.), since 1956, with over 500 acres of active agricultural crops across Yolo County that support dozens of local jobs.

## Accomplishments



#### Living up to our Fiscal Responsibilities

Just 2.5 years after launch, VCE has already made its final installment to the Sacramento Municipal Utility District (SMUD) for their assistance with operating services during our launch. The \$1.5 million in deferred charges and interest were paid off right on schedule.

This is the second of VCE's financial commitments that have been well met—the first included seed loans from its 3 founding jurisdictions of Davis, Woodland, and Yolo County, which were repaid years ahead of schedule.

#### **Community Choice is Working in California!**

CCAs are expected to supply 36% of the electricity load in the state by 2022, according to the latest annual report of the California Community Choice Association in November.

VCE is one of 23 operational Community Choice programs in the state, which have collectively contracted for over 6,000 megawatts of NEW renewable energy. Forty-six percent of the new solar projects include storage. We couldn't be prouder! And we couldn't have done it without YOU.





#### Welcome, Winters Customers!

Just weeks from now, on January 1st, Winters will join Davis, Woodland and unincorporated Yolo County in receiving electricity from VCE, with an immediate increase in the amount of renewables in their electricity. Our competitive pricing means that PG&E rates will be matched.

Residential and commercial customers will be enrolled in January, unless they have solar panels. Solar customers will roll in during their PG&E true-up month to ensure against the loss of any generation credits they may have accrued. The Winters City Council voted unanimously to join VCE last year and we're so excited to be officially "flipping the switch."

As you know, that means that every VCE electricity customer in Winters will have <u>cleaner</u>, <u>greener electricity without paying any more</u> than they have been.

So many people talk about wanting to make a difference on climate, but they don't know where to start. Now Winters customers, just like most of Yolo County, will be able to make a difference without having to do a thing.

If you're able to make a greater effort, please opt up to our 100% renewable, carbon-free UltraGreen service. It costs just 1.5 cents more per kWh, and will virtually eliminate your carbon footprint from electricity use. This is only about \$3-7 a month extra, depending on your usage.
